The data you supply to the manager of the tourist accommodation, who acts as the person responsible for its processing, is supplied in order to comply with the obligations described by art. 4 of the regulations on tourist tax of the Municipality of Trieste. It is necessary to supply your personal data in order to obtain the exemption requested. If you refuse to provide your personal details, it will not be possible for you to be granted your exemption. The manager of the tourist accommodation has an obligation to keep this declaration for five years in order to allow fiscal checks on the part of the Municipality, to whom this data may be communicated; for such checks, the manager acts as the person responsible for processing of the data. Furthermore, we would like to point out that the processing carried out by the Municipality may be automated or manual, in accordance with what is described in art. 32 of GDPR 2016/679 and annex B of the Italian legislative decree 196/2003 (art. 33 to 36 of the Code) on the matter of security measures. The processing will be carried out by personnel who are suitably authorised to do so in compliance with what is described in art. 29 GDPR 2016/679. You may exercise your rights at any time when dealing with the manager of the establishment receiving this declaration as well as with the Municipality, in their function as the body responsible for processing, pursuant to art. 7 of the Italian legislative decree 196/2003 and art. 15 onwards of the GDPR - EU Regulation 2016/679.
